Release & Waiver of Liability, Assumption of Risk, and Indemnity & Parental Consent Agreement In consideration of being permitted to participate in any way in soccer or other sports (“Activity”) I, for myself for personal representatives, assigns, heirs, and next of kin: 1. Acknowledge, agree, and represent that I understand the nature of sports and that I am qualified and in proper physical condition to participate in such Activity. I agree and warrant that, if at any time I believe conditions to be unsafe, I will immediately discontinue participation in the Activity. 2. Fully understand that: (a) soccer, and other sports involve risks and dangers of serious bodily injury, including permanent disability, paralysis, and death (“Risks”); (b) these Risks may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or the negligence of the “releasees” named; (c) there may be other risk and social and economic losses either not known to me or not readily foreseeable at this time, and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation or that of the minor in the Activity. 3. Hereby release, discharge, and covenant not to sue The Sports Factory of NEPA, LLC, their respective administrators, directors, agents, officers, members, volunteers, employees, other participants, sponsors, advertisers, owners, and lessors of premises on which the Activity takes place, (each considered one of the “Releasees” herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the “releasees” or otherwise, including negligent rescue operations and I further agree that if, despite this release and waiver of liability, assumption of risk, and indemnity agreement I, or anyone on my behalf, makes a claim against any of the releasees, I will indemnify, save, and hold harmless each of the releasees from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim. 4. I understand and acknowledge that The Sports Factory of NEPA, LLC has agreed to allow me to use its services, equipment, and facilities including agreeing to receive email announcements about new services, updates and schedules, on the condition that I sign this agreement. In addition, I agree to allow photographs of myself and my family to be used in the publication of The Sports Factory of NEPA, LLC brochures, flyers or on social media. I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect. Minor Release And I, the minor’s parent and/or legal guardian, understand the nature of soccer, and other sports and the minor’s experience and capabilities and believe the minor to be qualified, in good health, and in proper physical condition to participate in such activity. I hereby release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless each of the releasees from all liability claims, demands, losses, or damages on the minor’s account caused or alleged to be caused in whole or in part by the negligence of the releasees or otherwise, including negligent rescue operation and further agree that if, despite this release, I, the minor, or anyone on the minor’s behalf makes a claim against any of the releasees named above, I will indemnify, save, and hold harmless each of the releasees from any litigation expenses, attorney fees, loss liability, damage, or cost any may incur as the result of any such claim.
